- b) Jaci and Brad met Saturday, got signatures on letters to NMC and County Commissioners.
- c) Wed. Aug 7<sup>th</sup> mower and weed eater were stolen from the cemetery. Insurance will cover loss. No leads at this time. Council member Jenson asked why the cemetery has not been locked up at night. Reimer said that the cemetery district members had been receiving complaints from people who wanted to be able to go into the cemetery at their will. The cemetery board needs to approve the closing of the cemetery and heavier gates need to be erected.
- d) Summer help has gone back to school. Kris Hooper will continue on-the-job training from 12:30 – 3PM.
- e) 2 new personnel are working out well. Rick Wheeler, Sewer Operator has done very well with the flooding issues at the sewer plant. Amanda Mabry, Utility Clerk is coming in at a hard time, shifting to a new software program to accommodate meter reading equipment.
- f) Flooding, Code Red and Weather Radios. There was over \$10,000 spent on barricade costs. The sign up for Code Red and weather radio sales has increased since the flooding.
- g) A Blood Drive will be held at Sedgwick Senior Center on September 7<sup>th</sup>. The blood mobile will park in front of building.
- h) LKM conference will be on Saturday, October 12 through Monday, October 14 in Overland Park. Jaci will be attending and will take one other staff person to be decided later. Voting delegates will be chosen next meeting.
- i) Next council meeting will be on Tuesday, Sept 3<sup>rd</sup> due to Labor Day.
