

**ORDINANCE NO. 738**

**AN ORDINANCE ESTABLISHING PROHIBITIONS AGAINST  
THE POSSESSION OR CARRYING OF CERTAIN FIREARMS  
WHILE UPON DESIGNATED PROPERTY OWNED AND/OR  
OPERATED BY THE CITY OF SEDGWICK, KANSAS.**

**BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF SEDGWICK,  
KANSAS:**

**SECTION 1.** As used in this ordinance, the term "firearm" shall mean any handgun, pistol, or revolver.

**SECTION 2.** Pursuant to the authority granted to property owners and to the owners or operators of businesses under the Personal and Family Protection Act, Chapter 32 of the 2006 Session Laws of Kansas, as amended by Chapter 210 of the 2006 Session Laws of Kansas, the governing body of the City of Sedgwick, Kansas, hereby prohibits the carrying of any concealed firearm by any person other than those identified in Section 5 below while in or upon the premises of any of the following properties which are owned by the City of Sedgwick, Kansas, and/or on which the City is operating as a public employer:

- (1) The Sedgwick Maintenance Shop located at 320 N. Washington, Sedgwick, Kansas;
- (2) The Sedgwick Fire and EMS Station located at 316 N. Washington, Sedgwick, Kansas;
- (3) The Sedgwick Wastewater Treatment Plant located at 1900 N. Washington, Sedgwick, Kansas;
- (4) The Sedgwick Recreation Center located at 120 N. Washington, Sedgwick, Kansas;
- (5) The Sedgwick Senior Center located at 107 W. 5<sup>th</sup>, Sedgwick, Kansas;
- (6) The Sedgwick Historical Museum located at 523 N. Commercial, Sedgwick, Kansas;
- (7) Any city park or playground within the City of Sedgwick, Kansas.

**SECTION 3.** Violation of Section 2 of this ordinance is a Class B violation.

**SECTION 4.** The prohibitions set forth in Section 2 above shall apply both to the interiors of the structures on all such properties and to the exterior areas; provided, however, that the prohibitions shall not apply to persons who are otherwise lawfully in possession of any such firearm while in a motor vehicle which is located in an area designated for public vehicular traffic or for public vehicular parking.


**SECTION 5.** The prohibitions set forth in Section 2 above shall not apply to any person identified under the exclusions set forth in subsections (b) or (c) of K.S.A. 21-4201 regarding the criminal use of weapons, as said provisions now apply or may hereafter be amended.

**SECTION 6.** This ordinance shall take effect and be in force from and after its publication in the official newspaper of said City.
